Splash and Dash Colour Run

Dear Parents and Carers

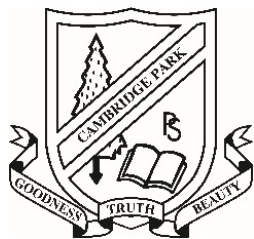
As you are aware the school is holding a Splash and Dash Colour Run on Thursday 8th August following our Bring Your Family to School Day. The "Splash" part of the run involves the use of a liquid colour being squirted at students' shirts by teachers and the "Dash" part involves students running past bubble machines and bubble wands during the event.

Please note, at no time during the event will water be thrown over the students to cause them to get saturated or overly wet, they may however have a dampness on their shirt from where the colour is squirted on them, if they participate in the colour event.

Whilst all students will be participating in this whole school event, your permission to participate in the colour run with liquid colour and bubbles is required.

Please note the following:

- ☐ The liquid colour is made from non toxic corn flour and food dye. Food colour and water will also be used during the event. The bubbles are made from dishwashing liquid, water and food dye.
- ☐ Students cannot participate in the colour run *with the liquid* if they are wearing school uniform. Students are invited to wear mufti clothing to school on the day. White clothing is preferred as this will highlight the colours used in the run. In most cases the colour will easily wash out of clothing however the school does not take any responsibility for colour stained clothes.
- ☐ As part of our identified safety measures,
 - o students have the option of running/walking the event *without* the use of colour and/or bubbles. Please identify below which event you wish for your child to participate in
 - o teachers and other adults will be squirting the liquid colour at students shirts
 - o sunglasses or goggles are preferred as an added safety measure to protect eyes from coloured powder
 - o students are able to wear a disposable wet weather poncho above or under their clothing should parents be concerned of the shirt being a little damp from the colour
 - o Splash and Dash Colour Run will be run from approximately 1:30pm – 3pm to ensure they are participating at the warmest part of the day for that time of year
 - o should the weather be questionable on the day the event will be postponed to another day
 - o whilst students will be going home directly after the event they are also able to bring a change of shirt or towel for after the event
- ☐ Parents are welcome to join their children in a combined parent/child run with or without colour after all classes have completed the run.
- ☐ Although this is a school fundraiser through students gaining sponsorship, there is no cost to participate in the colour run on the day.
- ☐ Students who do not return a permission note or arrive at school in uniform will automatically be placed in the non colour event.
- ☐ This activity has the approval of the Principal.

A failure to provide the information may mean that your child can not participate in a particular excursion or school activity. In such circumstances the school will make available a sound alternative educational experience.

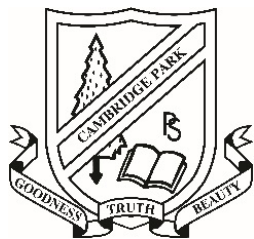

IMPORTANT NOTE:

- Supplying the medication and any 'consumables' necessary for its administration in a timely way.
- Collaborating with the school in working out arrangements for the supply and administration of the prescribed medication for the duration of the excursion.
- For some excursions the school will ask you to supply the medication in a different way to what has been already been agreed to by school. You may be asked to supply an additional adrenaline auto injector (i.e. EpiPen®) for example.
- The medication should be well within its expiry date.
