### CARES Road Safety Centre - Years 4, 5 and 6

Dear Parents / Caregivers,

We have been fortunate to be able to book 3 sessions at the Community and Road Education Scheme (CARES) at St Marys for our students in Year 4, 5 and 6. At the CARES course, students will be taken through sessions about road safety including: bus, passenger and bicycle safety. Students will have an opportunity to ride the centre's bikes as part of the lessons. Pre-visit lessons and follow up lessons will be conducted at the school. The instructor at the Centre is a Senior Constable. There is a limit of 30 students per day.

Students will be supervised by Miss Poole, Mrs Sanders and Mrs McGilvray who have current training in emergency care, anaphylaxis and CPR.

### WHAT TO TAKE:

- 1. Food for recess and lunch. Plenty of drinks for the day ( No canteen facilities are available)
- 2. Bicycle Helmet. It must be an approved helmet with the standards of Australia sticker (there are only a few helmets at the centre for those students who do not own one)
- 3. School uniform. Students must wear shorts or pants.
- 4. Girls with long hair need to have it tied back in a low ponytail
- 5. Covered lace up shoes
- 6. Hats and Sunscreen

COST: \$10.00 per student is required for the bus transport. Payment is required by Monday 14 October 2019
